CONTRACTOR AGREEMENT

THIS CONTRACT (THE "AGREEMENT") is made and entered into this 21st day of September A.D 2021. By and between the CENTRAL AGRICULTURAL RESEARCH INSTITUTE (CARI), Represented by its authorized officer, the Director General, Dr. Victor H. Sumo, of the District of Suakoko, Bong County, Republic of Liberia, herein known and referred to as the Purchaser/Procuring Entity and MA BENDU FARMS of Fendell/Lower Careysburg, Montserrado County, Republic of Liberia aforesaid (hereinafter known and referred to as the (Contractor "), hereby

WITHNESSETH

Whereas, the contractor is an entity organized and existing under the law of the Republic of Liberia to do business in the Republic of Liberia.

Whereas, the contractor has received communication from the procuring entity and is willing to supply the procuring entity with **Agricultural Inputs** required in Lot 1: **Agricultural Chemicals** and Fertilizers & lot 2: Agricultural Tools, of the contract.

WHEREAS, the contractor is a company/business, having all the warrants providing the procuring entity with Agricultural Chemicals, Fertilizers & Tools, and engaging into the business of selling agriculture supplies within the Republic of Liberia

Whereas, the contractor desires and hereby warrants providing the procuring entity with Agricultural Chemicals, Fertilizers & Tools.

Now therefore, with the view of realizing and putting into effect this contractual agreement, the parties hereto covenant and mutually agree to the following terms and conditions:

ACTICLE 1: SCOPE OF WORK

I. Under this contract, the contractor shall supply to the purchaser the following:

- II. Provide quality **Agricultural Chemicals, Fertilizers and tools** to the purchaser for the fiscal year 2021(special budget year) with funding from the government of the Republic of Liberia.
- III. Provide when presented a purchase order approved by the Ministry of finance, the Agricultural Chemicals, Fertilizers & Tools meeting the specification in the bid document
- IV. As and when good are supply, the contractor will present delivery note evidencing goods delivered to the Central Agricultural Research Institute (CARI) for payment to the Contractor.
- V. The goods will be delivered by the contractor at the warehouse of the Central Agricultural Research Institute (CARI) with the required specifications and qualities.
- VI. Payment will be made on Delivery Note and Credit Invoice.

ACTICLE II: COST

It is mutually agreed by both parties that the total cost of this agreement for the supply of Agricultural Chemicals and Fertilizers shall not exceed the amount of US\$62,390.00 (SIXTY TWO THOUSAND THREE HUNDRED NINTY UNITED STATES DOLLARS).

ARTICLE III: WARRANTY

It is mutually agreed that the contractor shall provide the goods based upon the purchaser request during this contractual agreement. All goods should have an expired date of not less than one year from date of delivery.



the procuring entity shall terminate the contract and the contractor shall pay to the purchaser all expenses and related cost.

2. In the event the agreement is terminated by the purchaser, all outstanding goods paid for

shall be supplied by Ma Bendu Farms.

3. During the term of the contract, either party may terminate the contract by giving the other party at least thirty (30) days prior notice. In the event that the purchaser shall terminate the contract, the contractor shall be obligated to the purchaser, only for the amount of goods supplied to the purchaser, and in the event that the contractor shall terminate this contract, the purchaser shall not be obligated to the contractor.

ARTICLE IX: DISPUTE RESOLUTION

The parties shall make every effort to amicably resolve any disagreement or dispute arising between them under or in connection with this contract. The party asserting the existing disagreement shall notify the other party in writing specifying the nature of the disagreement or dispute, and shall provide detail information about the disagreement or dispute, as the other party may reasonably require. When the issue cannot be resolved using the abovementioned means, the dissatisfied party shall take legal actions.

ARTICLE X : FORCE MAJEURE

It is also agreed and understood by the parties hereto that in the event of hostilities including civil disturbance, natural disaster or act beyond the control or either or both parties, it shall be construed as force majeure; the effect of such event shall be suspension of the obligations of each party until the cessation of the force majeure.

THIS CONTRACT AGREEMENT is binding on the PARTIES, their representatives, heirs, assigns, successors-in-office for the herein specified contract period, as if they were specifically named herein.
