The vehicles are urgently needed to replace defective vehicles on the Presidential Motorcade which have outlived their usefulness and are no longer road worthy.

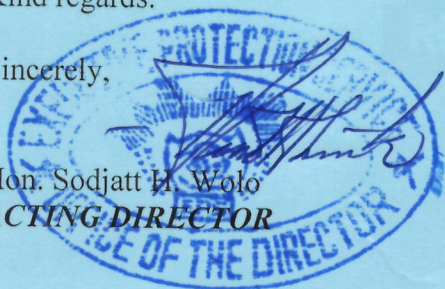
In view of the above, the Executive Protection Service is assured of your usual support in this regard as urgency is hereby attached.


Subject: **'Response to EPS's Request for No Objection to Sole Source 14 Land Cruiser from CICA Motors**
