NEWSPAPER SUPPLY AGREEMENT

This Newspaper Supply Agreement made and entered into this 1st day of July, A.D 2019, between the **General Auditing Commission (GAC)** represented by and through its Deputy Auditor General, **Hon. Foday G. Kaizolu**, hereinafter known and referred to as "Consumer", and the **John T. Manjoe Media & Marketing Services** represented by its owner **John T. Manjoe** hereinafter known and referred to as "Supplier", hereby;

WITNESSETH:


Whereas, the GAC, the independent Supreme Audit Institution of the Government of the Republic of Liberia, having its principal place of business at Old Executive Mansion Building, Ashmun Street, Monrovia and John T. Manjoe Media & Marketing Services, a registered business under the laws of the Republic of Liberia, intend to create a Newspaper Supply Agreement in compliance with Clause 4 of this agreement;

Now therefore, the Purchaser and the Supplier have agreed on the following terms and conditions:


1. That the Supplier shall deliver assorted newspapers to the Purchaser on a daily (working days) basis with the total daily (adjusted) costs attached;
2. That the said supplies shall be delivered directly to the Purchaser at Purchaser's principal place of business at Old Executive Mansion Building, Ashmun Street, Monrovia;
3. That the Purchaser with the consent of the Supplier shall pay the total tabulated costs of the Newspaper to the Supplier at the end of every two (2) weeks except for constraints;
4. That the duration of this Newspaper Supply Agreement is one (1) fiscal year of the Government of Liberia, which expires on June 30th, 2020; and renewable upon terms and conditions to be agreed upon by the parties herein;
5. That this Agreement sets forth the parties' entire understanding relating to this subject matter;
6. This Agreement, in spite of its duration, may be terminated by any of the parties herein by giving a one month notice to the other Party.
7. This Agreement Takes binding effect as of the signing of the parties hereto.

In witness whereof the parties hereto have caused this agreement to be executed in accordance with the laws of the Republic of Liberia on the 1st day of July, A.D. 2019.




