FRAMEWORK CONTRACT FOR THE PROVISION OF GENERATOR REPAIR AND MAINTENANCE SERVICE

THIS FRAMEWORK CONTRACT, made and entered into on this 4th Day of April, A.D. 2022, by and between the General Auditing Commission (GAC), The Independent Supreme Audit Institution of the Government of the Republic of Liberia with its principal Office at Old Executive Mansion Building, Ashmun Street Building, Monrovia, Liberia, represented by and thru its Deputy Auditor General for Administration, Hon. Foday G. Kiazolu, hereinafter called ("The Client") and Techno Tech Inc., a business entity operating under the laws of the Republic of Liberia and having its principal place of business at Randall Street, Monrovia, Republic of Liberia, represented by and thru its Managing Director (MD), Mr. Moussa Hamdoun, hereinafter called ("The Service Provider"); hereby:

WITNESSETH:

Whereas, "The Client" conducted a Request for Quotations (RFQ) bid proceeding for Generator Repair and Maintenance Service in which the Service Provider's quotation was evaluated and met all requirements stipulated in the RFQ; and the Quotation has been accepted as the most responsive evaluated quotation to provide Generator Repair and Maintenance Service for the fiscal year January 1, 2022 – December 31, 2022;

NOW THEREFORE "THE CLIENT" AND "THE SERVICE PROVIDER" HAVE AGREED AS FOLLOWS:

TERMS AND CONDITIONS

- 1. This framework agreement is based on **pre-agreed unit prices** for the provision and delivery of Generator Repair and Maintenance Service (hereinafter called "the Unit Prices").
- 2. It is expected that up to Fifteen Thousand United States dollars (USD \$15,000.00) worth of Generator Repair and Maintenance Service will be provided within the contract period. These are services that will be required from time to time by the GAC.
- 3. As and when these services are performed by the Service Provider for the Client, the Service Provider will present for payment, invoices and delivery notes evidencing effected performance and delivery of service to the General Auditing Commission for payment. Payment will be made at the end of each successful service performance in USD/LD, after a satisfactory job completion report is submitted by Asset, Facility and Fleet Management (AFFM) unit of the GAC.
- 4. That the parties also have agreed that the Client shall deduct applicable Government of Liberia withholding tax from the Contract Price on each payment and pay same on behalf of the Service Provider to the Government of Liberia. The Client shall return payment (flag) receipt to the Service Provider within 30 days after payment.
- 5. "The Client" will submit to "The Service Provider" signed and approved service request before any service is performed.

- 6. The maximum duration of the agreement is limited to this fiscal year 2022 (April 4 December 31). The Unit price will remain unchanged during the period of contract.
- 7. It is agreed and understood by the parties that not all of the services listed in the Service Provider's quotation that will be performed each time a service request is made. The services listed in the Service Provider's quotation will be performed only when required. This will be supported by an assessment report submitted by the Service Provider to the Client, outlining the services to be performed.

This specific procurement is made throughout the term of the agreement as follows:

- 1. That in this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to below.
- 2. That the following documents shall be read and construed as an integral part of this Contract:
 - > This Contract Agreement
 - Schedule(s) of requirements
 - Service Provider's original quotation
 - > Technical Specifications
