Framework Agreement for Goods

THIS FRAMEWORK AGREEMENT is made the 16st day of December, 2020

BETWEEN GSA(hereinafter called "the Purchaser") and Super Petroleum(hereinafter called "the Supplier") a corporation incorporated under the laws of the Republic of Liberia and having its principal place of business at Capitol Bye-Pass, Monrovia.

The Purchaser intends to apply a portion of its budgetary allocation for the fiscal year 2020/20 to the procurement of Petroleum products.

Terms and Conditions

The tramework agreement is cased on prevailing unit prices as offered by the Supplier and accepted by the Purchaser for the supply and delivery of Petroleum Products.

It is expected that substantial amount of Petroleum Products will be procured within the agreement period through individual contracts based on Purchase Order Form issued by the Purchaser under this agreement. These are Petroleum Products that will be required from time to time by the same Purchaser.

As and when these items are supplied to the Purchaser, the supplier will present for payment, invoices and waybills evidencing effected supply and delivery of Petroleum Products to the Purchaser for payment.

The maximum duration of the agreement is limited to 2020/2021 fiscal year. The unit price will be the prevailing prices during the period of agreement.

This specific procurement is made throughout the term of the agreement AS FOLLOWS:

Purchase Order Form. The delivery schedule will start at the date of agreement signature.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 4. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of this Agreement.
