RE: REQUEST FOR "NO OBJECTION" TO USE THE RESTRICTED BIDDING METHOD OF PROCUREMENT FOR VEHICLES PURCHASE WITH REDUCTION IN PUBLICATION TIME FOR FISCAL 2023

Dear Mr. Stevenson S. Yond

We write in compliance with section 50 count (a) of the Public Procurement and Concessions Act (PPCA) of 2010, requesting for "No objection" to the use of Restricted Bidding Method for the procurement of two motor vehicles for the use of the Commission (INCHR). Due to the following:

- 1. Lack of funds to advertise the bidding process
- 2. Minimize the cost associated with printing bidding documents
- 3. Due to the limited number of supplies in the sale of vehicles

According to the law here in cited above, Restricted Bidding Method for the reduction of lead time maybe use, subject to the approval of the Commission (PPCC), when the goods, works or services, are only available from a limited number of bidders.

As stated herein, the supplies for the sale of vehicles in Liberia are limited thereby limiting the number of bidders for the purchase of said vehicle. Additionally, the Commission (INCHR) lack funds to advertise bidding processes in keeping with regular procurement activities; hence, our request for "No objection" for Restricted Bidding.

I look forward to a timely response from you as soon as possible.

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Concessions Commission deems it a **priority** that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
