### REQUIREMENT FRAMEWORK AGREEMENT

THIS REQUIREMENT FRAMEWORK FOR THE SUPPLY AND DELIVERY OF **SUPERMARKET FOOD ITEMS** is made and entered into this 6<sup>th</sup> day of October, A.D. 2020 by and between the Government of the Republic of Liberia, through the John F. Kennedy Memorial Medical Center, represented by its Chief Executive Officer, **Dr. Jerry F. Brown** (hereinafter known and referred to as the Purchaser), and Exclusive Super Store., a duly authorized \*Supermarket Food Items distributor operating under the laws of the Republic of Liberia, represented by its General Manager, **Mr. Uttam Sahajwani** (hereinafter known and referred to as the Supplier /Contractor) now hereby

#### WITNESSETH:

**WHEREAS** the Center has budgetary allotment from the Government of Liberia for the procurement of Supermarket Food Items to support its operations;

**AND WHEREAS** the Center, in keeping with law, has submitted a complete set of bidding document in English to importers and distributors of Supermarket Food Items as a requirement through a process of **National Competitive Bidding NCB**;

**AND WHEREAS** after due process of bid evaluation, the Procurement Committee endorsed the selection of the Supplier/Contractor as having the most competitive bid and has therefore been awarded this contract for the supply of the said **Supermarket Food Items** (See bidding documents attached as **Exhibit A**);

**AND WHEREAS** The Contractor, in keeping with law, has submitted the following documentations as proof of its legal status:

- a) Business registration for the current year
- b) Valid Tax Clearance
- c) A Registered Member of PPCC Vendor Registry

(See documents attached as **Exhibit B**)

**AND WHEREAS** the Contractor represents that it possesses the necessary capacity, knowledge, ability and experience to implement this contract;

AND WHEREAS, the Contractor represents that neither it nor any of its officers, employees or persons acting on its behalf have performed any of the following acts:

- Attempted to influence the actions of John F. Kennedy Memorial Medical Center officials in connection with the award of this contract;
- Offered any inducements, rewards or anything of value to the Center's officials or employees or their relatives in connection with the award of this contract;

NOW THEREFORE the Medical Center and the Supplier/Contractor agree to the following terms and conditions:

### 1. DESCRIPTION OF GOODS

The Parties agree that the products to be supplied are **Supermarket Food Items** and will be available at all times without delay or hindrance.

### 2. CONTRACT VALUE AND PAYMENT TERMS

The parties agreed that the total value of this contract shall be **One Hundred Thousand United State Dollars 95/100(US\$100,000.00)**, which constitute the full amount on the Procurement Plan, shall be used for the purpose of procuring supermarket food items for patients feeding.

The parties agreed that payments will be made against the Contractor's invoice for quantities supplied by an **Approved Purchase Order** from the Purchaser. All such payments are to be made within thirty (30) days of the presentation of invoice. There will be no overlapping of the supply of Supermarket Food Items under this contract. Prices on Contractor's invoices shall be as same as prices quoted in bid document. Any change thereof without notifying the Center will be considered as an attempt to defraud and thus warrants immediate termination of this agreement.

The parties also agree that there will be no advance payments under this contract.

### 3. PRICE ADJUSTMENT

Prices quoted herein are subject to review where the Supermarket Food Items issued by the Company are based on current market price. Prices may be adjusted whenever the Government of Liberia adjusts prices upwards or downwards. However, there shall be no unilateral adjustment of prices except by written communication be the parties.

#### 4. DURATION

The parties agree that this contract shall be for the fiscal year 2020/2021 constituting Nine (9) calendar Months beginning **October 6, 2020** up to and including **the 30<sup>th</sup> day of June, A.D. 2021**.

#### 5. CONTRACT MODIFICATION OR EXTENSION

The parties agree that this contract may be modified in whole or in part only with the written consent of both parties and under terms and conditions to be negotiated. Any such modifications shall be duly executed as an addendum, and may be requested by either party. The parties agree that no portion of this contract may be subcontracted to any other party except with the express written consent of the JFK Medical Center.

#### 6. TERMINATION

A. **Contractor's Right to Terminate:** If the Medical Center fails to pay the Contractor within a reasonable time any sums already certified by the Center, then the Contractor may, upon Thirty-Five (35) business days' written notice to the Medical Center, stop the supply and demand payment from the Center for all food stuffs supplied prior to the notice. The parties agreed that presentation of an invoice shall constitute written notice.

B. **Medical Center's Right to Terminate:** In the event the Contractor failed to supply the products as requested by the Center's Purchase Order, the Center shall give written notice requiring the Contractor to supply within ten (10) business days. Should the Contractor refuse to comply with the Center's instruction and warning to correct the deviation(s), the Center, without prejudice to any other rights or remedies, may terminate the contract, find another supplier and provide the products by whatever means the Center may deem expedient. The Center also reserves the right to terminate this agreement under section 2 as stated herein above

In the event of the Center's termination, any payment due the Contractor shall be withheld by the Center as liquidated damages incurred by the Center due to the Contractor's default.

C. **Center's Right to Terminate for Corrupt or Fraudulent Practices:** The Center may, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Contractor, terminate the Contract in whole or in part if the

Contractor, in the judgment of the Center has engaged in corrupt or fraudulent practices in executing the Contract. For the purpose of this clause:

- i. "corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
- ii. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the benefits of free and open competition.

D. **Center's Right to Terminate for Insolvency:** The Center may at any time terminate the Contract by giving written notice to the Contractor, without compensation to the Contractor, if the Contractor becomes bankrupt or otherwise insolvent, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the Center.

E. **Center's Right to Terminate for Convenience:** The Center, by written notice sent to the Contractor, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination be for the Center's convenience, the extent to which performance of the Contractor under the Contract is terminated, and the date upon which such termination becomes effective. Any supplies that are complete and ready for payment shall be accepted by the Center at the Contract terms and prices based on the Government of Liberia adjusted prices.

## 7. FORCE MAJEURE

In the event of force majeure due to acts of God, civil war or disturbances, or other acts beyond the control of the parties that make the performance of this Contract impossible, the Contract shall be suspended for the said period of force majeure to be resumed as soon as circumstances can allow. In any such case, the duration of the contract shall be negotiated to compensate for the period of suspension.

#### **8. ENTIRE AGREEMENT**

This Contract and the attachments hereto made constitutes the entire agreement between the parties relating to the subject matter hereunder, and supersedes any and all oral statements, discussions, representations or agreements made by either party to the other.

#### **9. ENFORCEABILITY**

Failure on the part of either party to enforce any provision of this Contract shall not be construed as a general waiver or relinquishment of the right to enforce such provision. If any provision shall be held unenforceable, the validity, legality and enforceability of the remaining provisions shall in no way be affected thereby, and shall remain binding on the Parties.

#### **10. NOTICE**

All notices, requests, consents and other communication hereunder shall be writing in English and shall be forwarded by either registered mail, facsimile, email or hand delivered to the address of each Party as follows:


