The Commission upon review of your request and overall scrutiny, observes the following:



- That **Millennium Construction Inc.** emerged as the successful responsive bidder.

The Commission, upon review of all submitted documentations and subsequent clarifications, states the below:

That the Commission renders "No Objection" to the John F. Kennedy Medical Center to award contract to **Millennium Construction Inc.** for the renovation of 4th floor VIP Suite and in the stipulated amount of five hundred forty-six thousand three hundred two United States Dollars and ninety-six cents (**US\$546,302.96**).

Please note that given the contract value exceeding the threshold amount of **US\$250,000.00**, **it must be duly signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.** We ask that you kindly forward a copy of the final contract be submitted to the Commission for **validity and reporting as required by the PPCA.**

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
