

We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Judicial Branch Non-SBA Procurement Plan for the purchase of one (1) new vehicle as per the Judicial Branch request for the use of the Court Administrator's office in accordance with **Section 40** (3) of the PPCA, 2010, and Section 55(d).

The Commission conveys to the Judicial Branch that this Procurement Plan will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plan, upon conclusion of stipulated processes.

Please note that all contracts which cumulative annual value above the threshold of US\$250,000.00 must be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice. The Commission requires that you kindly forward copies of all stipulated contracts upon signing, so as to update our records.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA 2010 as we jointly aspire to ensure the National Interest is assured and ultimately public confidence is maintained in all Public Procurement and Concession processes.
