A request for quotation (RFQ) process shall be conducted. For this package, a sum of USD\$1,000.00 has been allocated to line "Repairs and Maintenance-Vehicles" in the July To December 2021 Special Fiscal Year budget.	Funds from this line shall be used to contract a reliable company for the supply of assorted stationary and supplies for the Commission. A request for quotation process shall be conducted. For this package, a sum of USD \$1,142.00 has been allocated to line "Stationery" in the July To December 2021 Special Fiscal Year budget. The assorted stationery and supplies shall include 5 cartons of A4 paper, 2 cartons of legal paper, 1 cartons of manilla folders, 1 carton of boxfiles, 1 carton of pens, 5 sets of ink cartridges, 5 pieces of toners, 1 carton of staples pins, 1 carton of staple machines, etc.	Funds from this line shall be used to contract a reliable company for the supply of 2,750 gallons of petroleum products (diesel and gasoline) to the Commission.
