Framework Agreement for the Supply and delivery of Furniture

This Framework Agreement is made and entered into this 30th day of November AD 2020 by and between the Liberia Broadcasting System hereinafter called "the Purchaser" and the Mattar Trading Company a dually registered Business under the laws of the Republic of Liberia and having its principal place of business at Center Street hereinafter called "the Supplier". The Liberia Broadcasting System intends to apply portion of its budgetary allocation to the procurement of LOT 1 assorted furniture under the package (Furniture & Fixtures IFB NO LBS/RFQ/003/20/21).

This framework agreement is based on pre agreed unit price as quoted on the Original RFQ Mark (IFB NO. LBS/RFQ/003/20/21) CONFIDENTIAL. QUOTATION FOR THE SUPPLY and DELIVERY OF FURNITURE LOT 1, (hereinafter called "the unit price"). It is expected that up to about the same amount of quantities in the (RFQ) of furniture will be procured within the contract period. These are goods that will be required from time to time by the Liberia Broadcasting System.

Payment Term: As and when these items are supplied to the Liberia Broadcasting System, the supplier will present for payment, invoices, and delivery note/waybills evidencing effected supply and delivery to the Liberia Broadcasting System for payment and all payments to the Supplier shall be made in United States Dollars or its equivalent in Liberian Dollars at the prevailing Central Bank exchange rate and payment term shall be at most thirty (30) working days from date of invoice or delivery note and payment shall be made by checks in favor of the Supplier and paid to its designated officer within the term stated herein, except otherwise agreed by both parties.

Duration of contract: The maximum duration of this agreement is limited to ofte (1) fiscal year. The unit price will remain unchanged during the period of this Framework Agreement.

NOW THIS AGREEMENT WITNESSTH ACCOLLOWS:

- 1. That the Supplier shall supply, upon request by the Buyer, certain quantity of Furniture to the Buyer for its operational use in Monrovia as specified by the buyer's purchase orders.
- 2. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the condition of contract referred to.
- 3. The following documents shall constitute the Framework Agreement between the purchaser and the supplier, and each shall read and construed as an integral part of the contract

 - > Technical specifications
 - Schedule(s) of delivery
 - > List and location of for emivery

- goods and services and to remedy defects therein in conformity in all respects with t provision of the contract.
- 6. The purchaser shall make payments to the supplier on delivery and acceptance of t goods as well as submission of delivery note, invoice and a waybill.
- 7. **Technical specification:** the supplier warrants that all the goods and related service comply with the technical specifications and other provisions of the agreement.
- 8. Warranty: the supplier warrants that all the goods are new, unused, and of the m recent or current models and that they incorporate all recent improvements in des and materials, unless provided otherwise in this Framework Agreement.

The Parties hereby agree that this Framework furniture Supply Agreement shall commence the 30th day of November A.D. 2020 and shall terminate on the 30th of June A.D. 2021. I further mutually agreed by the Parties that either Party may terminate this Agreement (with without fault) by giving the other Party at least THIRTY (30) DAYS written notice in advance.

That the foregoing constitutes the intent of the parties and same shall be binding upon the and their legal representatives and successors in business and/or office as if they we themselves parties and signatories to this Framework furniture Supply and delivery Agreeme
