### 1.0 Introduction and Summary

In keeping with Sections 27(g) and 43(9), of the Amended and Restated Public Procurement and Concession Act which requires each Procuring Entity to submit quarterly report to the Commission, I am pleased to submit the Procurement Report for the quarter July 1, 2022 – September 30, 2022 for your review and consideration.

During the period under review, The Liberia Broadcasting System *has* completed the implementation of **twelve (10 procurement packages out of the Thirty three (33) of the planned contract packages** within our provisional approved procurement plan for the period under review.

Out of the total procurement implemented thus far, the total number of contract packages acquired through each method of procurement along with the titles of the packages, for RFQ was used for the acquisition of three (3) contract packages (Assorted), whereas the NCB method of procurement was used for the acquirement of six (6) contract packages (Computer supplies and accessories, Air Tickets, vehicle Insurance, Scratch Cards, stationery & Repairs & Maintenance of vehicles). Additionally, the RB method was used to acquire one (1) package (petroleum product).

### 2.0 Challenges

One of the challenges is getting businesses, most especially Liberian businesses to take part in competitive bidding processes and those that will try taking part, will either submit incomplete documentations or will not follow the regulations of the bidding processes.

### 3.0 Recommendations

That the Public Procurement & Concessions Commissions (PPCC) conducts regular awareness and workshop aim at encouraging Liberian businesses to take advantage of procurement opportunities and bidding processes.

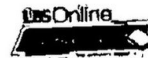
