Subject: **PPCC RESPONSE: "NO OBJECTION" TO AWARD CONTRACT TO PRIME CONTRACTORS INC. USING THE RFQ METHOD OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF LIGHT FUEL OIL (LFO) TO LEC BUSHROD ISLAND BULK STORAGE TANK FOR FISCAL YEAR 2024**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Liberia Electricity Corporation (LEC) to award contract to Prime Contractors Inc. using the RFQ method of procurement for fiscal year 2024.

The Commission, upon review of your submissions, highlights the following:

- That the Liberia Electricity Corporation submitted (**Hard copies**) including: transmittal letter, project procurement plan, RFQ bidding document, LFO special budget;
- That the estimated amount of **US\$2,150,000.00** as stipulated in the LEC's submitted project procurement plan exceeds the threshold amount of **US\$10,000.00** for the use of the RFQ method;
- That LEC's employed procurement method is inconsistent with the schedule of threshold for the use of RFQ for the award of contract to its recommended winner;

The Commission, upon overall review, scrutiny of the LEC's submission and accompanying documents, hereby states the below:

- That the Project Procurement Package (Light Fuel Oil) is urgently needed by the LEC to meet key deliverables;
- That the LEC is advised to revised and resubmit its LFO Project Procurement Plan utilizing the use of the Restricted Bidding Method of procurement and the existing updated data base of suppliers.
- That the LEC is advised to expeditiously address the above to facilitate further review by the Commission.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
