SECURITY SERVICE CONTRACT BETWEEN
ALARM RESPONSE SECURITY GUARD SERVICE, INC.

AND

LIBERIA EXTRACTIVE INDUSTRIES TRANSPARENCY INITIATIVE (LEITI)

INTRODUCTION

This SERVICE CONTRACT for the Provision of Security Guard Services on the Premises of LEITI is made and entered into this 1st day of October A.D 2022 by and between the Liberian Extractive Industries Transparency Initiative (LEITI), represented by its Head of Secretariat, Mr. Jeffrey N. Yates (herein known and referred to as "LEITI"), and Alarm Response Security Guard Services, Inc., a Security Guard Service Firm duly registered and operating in the Republic of Liberia, also of the City of Monrovia, County of Montserrado, Republic of Liberia, (hereinafter known and referred to as the "SERVICE PROVIDER"), represented by its Chief Executive Officer (CEO)/ Director, Marvin G.M. Gwion.

The LEITI and the SERVICE PROVIDER are hereinafter collectively referred to as the "Parties".

RECITAL

WHEREAS, the LEITI did invite quotations from Security Guard Service Firms for the provision of 3 shifts, Four(4) Guards Security Services on the premises of LEITI;

WHEREAS, the SERVICE PROVIDER responded to the LEITI's Request for Quotation(RFQ) by submitting a quotation in which it offered to provide 3-shifts, 8 hours with 4 Guards inclusive of the current LEITI Security Personnel (Kalisa Davis & two others) Services for a total cost of US \$ 1,800.00 (One Thousand Eight Hundred United States Dollars – US\$ 150.00 per Guard);

- 3.0 Monitoring and Restriction of Assets and Visitors by Implementation of Visitors and Vehicles Log Books
- 4.0 Implementation of Fire Control Methods
- 5.0 Liaising with National or State Authority for backup if the need arises,
- 6.0 Deploying Vigilant, Trained and Uniform Personnel
- 7.0 Maintaining Accurate Record System (Security Report Writing)
- 8.0 Communicating Security Related issues in and on time; and
- 9.0 Performing all other legally necessary security services to ensure the proper execution of this agreement.

3.0 PAYMENT TERMS

For and in consideration of the services to be performed by the SERVICE PROVIDER, the LEITI shall pay to the SERVICE PROVIDER, and the SERVICE PROVIDER accept from the LEITI, the total contract price of US\$ 1,800.00 (One Thousand Eight Hundred United States Dollars).
