## NOTE:

In compliance with the guidelines and regulations set forth by the Public Procurement and Concession Act 2010, LISGIS intends to use the below methods of procurement in the execution of the Spot Check (special project) Procurement Plan. Though the estimated contract prices do exceed the ceiling thresholds, we request the reduction in lead time because of time constraints, owing to the fact that the annual work plan for the Spot Check Activities was signed on the 1<sup>st</sup> of February, 2021. Should we use the required lead time for each method, we will not be able to implement the activity within the budgeted period.

In anticipation of implementing the activity within the budgeted period to facilitate smooth and timely implementation of the Spot Check, we asked the PPCC to allow us use the reduced lead times as per attached procurement plan.
