#### 1.0 Introduction and Summary

In keeping with Sections 27(g) and 43(9), of the Amended and Restated Public Procurement and Concession Act which requires each Procuring Entity to submit quarterly report to the Commission, I am pleased to submit the Procurement Report for the 1<sup>st</sup> Quarter (January-March), for your review and consideration.

During the period under review, Liberia Medicines and Health Products Regulatory Authority (LMHRA) has completed the implementation of Five (5) procurement packages out of the thirty (30) approved planned procurement packages of contract packages within our approved procurement plan for the period under review.

Out of the total procurement implemented thus far, the SS method was used for the acquisition of one (1) contract packages (Internet Connectivity IFBNO.LMHRA/SBA/SS/001/2023 and), the RFQ the acquisition of one (1) contract package (Publication method was used for IFBNO.LMHRA/SBA/RFQ/001/2023), the RB was used for the acquisition of one contract package ( Petroleum Products IFBNO.LMHRA/SBA/RB/002/2023) and the NCB method was used for the acquisition of (2) contract package (Security Guard Service two IFBNO.LMHRA/SBA/NCB/004/2023) Non-life and Personnel Insurance Coverage (IFBNO.LMHRA/SBA/NCB/005/2023).

#### 2.0 Challenges

During the course of the period under review the following challenges and constraints were encountered: delay in the passage of the national budget, delay in the development of our internal budget and cash plan, no budgetary allotment from GOL to support the implementation of all of the planned procurement packages.

#### 3.0 Recommendations

Recommend that the Management of LMHRA better equip the Procurement Unit with more logistics which will enable the unit to be more effective. I recommend that Finance prepare the budget and cash plan in time which will ensure the timely preparation of the entity's procurement plan. PPCC resume the yearly or quarterly refresher or brush over workshop as is was done in the past to keep all public procurement practitioner up to date with all changes and adjustments templates, regulations and rules.
