Similarly, you are also advised to carry out procurement activities for non-recurrent procurement items in advance of the passage of the National Budget, but contracts for these packages MUST not be signed until the budget is approved by the President and you ascertain the availability of funding. Please ensure to include notifications of this information in the tender documents for both framework agreements and advance procurement. Upon passage of the National Special Budget 2021, you are required to submit a revised/updated procurement plan, detailed budget for LMHRA's allocation in the approved budget, Cash Plan, names and positions of Procurement Committee members for Budget Year 2021 and staff of your Procurement

Please be reminded to duly submit your contract award information for all procurement contracts awarded
