Subject: **"NO OBJECTION TO AWARD CONTRACT TO PETRO TRADE FOR THE SUPPLY OF PETROLEUM PRODUCTS FOR FISCAL YEAR 2023."**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Liberia National Fire Service to award Contract to Petro Trade for the supply of 18,919 gallons of Gasoline in coupons and 842.00 gallons of Diesel coupons in the amount of US\$77,700.00 (seventy-seven thousand seven hundred United States dollars for the Fiscal Year 2023).

That Commission, upon review of your submissions, highlights the following:

- That the Liberia National Fire Service submitted (Hard copies) including: copies of invitation to bid presented to vendors, copies of bid submitted by vendors, bid opening minutes, including attendance, copies of bid submitted by vendors, copy of bid evaluation report, copy of the standard bidding document received by vendors etc.
- That as per the NFS submission, 3 (three) companies were written to take part in the bidding process but only one vendor (Petro Trade) participated and emerged as the successful bidder.

The Commission upon overall Scrutiny of LNFS's submission and accompanying documents hereby states the below:

- That "No Objection" is rendered for the Liberia National Fire Service to award Petro Trade in the stipulated monthly amount not to exceed US\$6,416.66 (six thousand four hundred sixteen United States dollars and sixty-six cents).

Please note that all contracts which cumulative annual value above the threshold of US\$250,000.00 must be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
