Subject: RECEIPT AND APPROVAL OF LIBERIA NATIONAL POLICE SPECIAL EMERGENCY PROCUREMENT(PLAN 2) FOR FISCAL YEAR 2022 AND "NO OBJECTION" FOR REDUCTION IN LEAD TIME.

We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Liberia National Police Special Project Emergency Procurement (Plan 2) for Fiscal Year 2022, to use the NCB Procurement Method with a reduction in Lead time from 4 to 2 weeks renovation works of the Recruits Males Dormitory at the Liberia National Police Academy and Training School (LNPATS), in accordance with Section 40 (3) of the PPCA, 2010.

The Commission wishes to inform the LNP that its Procurement Plan will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plans, upon conclusion of stipulated processes.

The Commission advises that you observe **Section 40** (5) of the PPCA, 2010 which states that a Procuring Entity shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plan. The Commission and the Ministry responsible for Finance should be notified in writing of any material changes in the procurement plan and be provided with a copy of the updated procurement plan. Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Concessions Commission deems it a <u>priority</u> that you remain <u>primarily</u> in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.


Dear Atty. Kowo:
