We present our compliments and request **No Objection** from the Public Procurement & Concessions Commission (PPCC) to allow the Liberia National Police (LNP) to single source **MATELCO INC.** of Buzzy Quarter, Monrovia, Liberia, for the Procurement of **Non-Lethal Weapons** in the amount of One Million Three Hundred Seventy-Three Thousand United States Dollars (**US\$1,373,000.00**) and **Police Materials** (Anti-Riot Materials) in the amount of Seven Hundred Two Thousand Five Hundred Twenty-Nine United States Dollars (**US\$702,529.00**) for the upcoming October 10th, 2023 General and Presidential Elections.

Our reasons for single sourcing MATELCO INC. are as follows:

1. MATELCO INC is a registered and recognized dealer of Non-Leather Weapons and Security Equipment in Liberia which the LNP has in the past conducted similar business with.
2. That the supply in question is highly sensitive and security related in which said procurement prohibits open competitions.
3. That the supplies in question are needed urgently by the LNP to help enhance its Law enforcement capacity for the maintenance of peaceful environment during the October 10, 2023 General and Presidential Elections.
4. That the funding for these supplies were made available to the LNP in July, 2023.
