

Subject: RECEIPT AND APPROVAL OF THE LIBERIA NATIONAL POLICE SPECIAL PROJECT PROCUREMENT PLAN FOR FISCAL YEAR 2020/2021

We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Liberia National Police Special Project Procurement Plan (Nonlethal Weapons) for Fiscal Year 2020/2021 in accordance with Section 40 (3) of the PPCA, 2010. The Commission informs the LNP that its Special Project Procurement Plan has been duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plans.

The Commission counsels that you observe Section 40(5) of the PPCA, 2010 which states "each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. An updated procurement plan shall accompany said notice to the Commission."

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method. The LNP is advised to utilize the PPCA Section 56 (1) to ensure value for money for the contract package and

subsequently, the final copy of the contract should be submitted to the Commission.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.


