MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING made and entered into this ____ day of June A. D. 2021 by and between the Liberia Petroleum Refining Company (LPRC) represented by its Managing Director, Hon. Marie Urey Coleman, (hereinafter known and referred to as Company) and EARTHTIME, Inc., represented by its Managing Director, Mr. Wassim Hamdan all of the City of Monrovia, Liberia (hereinafter referred to as Contractor) both the Contractor and the Company are collectively known as the Parties and individually as Party;

WITNESSETH

WHEREAS, the LPRC Board of Directors approved in the 2020/2021 Fiscal Budget funds for Laboratory Equipment, Wares and Supplies;

WHEREAS, the Company has expressed the desire for the delivery of Laboratory Equipment Wares & Supplies by the EARTHTIME, Inc. Winner for the (IFB. No. LPRC/NCB/011/20/21)

WHEREAS, the Procurement Unit conducted a National Competitive Bidding process for the delivery of Laboratory Equipment, Wares & Supplies in consistence with Section 48 of the PPC Act.

WHEREAS, a Bid Evaluation Panel was set up to evaluate the proposals received consistent with the PPC Act;

WHEREAS, the Bid Evaluation Panel submitted its report to the Procurement Committee and recommended EARTHTIME, Inc. for contract award as the responsive bidder;

WHEREAS, the Procurement Committee reviewed and endorsed the recommendation of the Bid Evaluation Panel;

WHEREAS, the existing conditions, requirement, terms and conditions have been under consideration and negotiation between the Company and the Contractor is found acceptable to both the Company and the Contractor;

NOW THEREFORE, with a view to realizing and putting into effect this instrument for the aforesaid the parties covenant and mutually agree to the following terms and conditions;

- 1. It is understood and agreed by the Parties hereto that the Procurement Unit and the Operations Department of LPRC is hereby designated to supervise and inspect the materials in order to ensure that the Laboratory Equipment, Wares & Supplies are correct and certify in accordance with the (IFB. No. LPRC/NCB/011/20/21). In the event any portion of the items to be delivered does not conform to the requirements of the contract, it shall be corrected by the Contractor immediately on its discovery.
- 2. All Laboratory Equipment, Wares & Supplies shall be subject to inspection and examination by LPRC's Procurement Unit and the Operations Department. The Company through the Procurement Unit and the Operations Department shall have the right to reject unsafe and damaged the Laboratory Equipment, Wares & Supplies and request their replacement or correction. Rejected materials shall be replaced to the satisfaction of the Company and without any charge to the Company.

DELIVERY SCHEDULE

3. It is mutually agreed by the Parties that EARTHIME INC. shall be responsible to deliver the Laboratory Equipment, Wares & Supplies within a period of forty-five (45) days upon receiving the first advance payment.

PAYMENT TERMS

4. It is mutually agreed by the Parties that the Company shall pay to the Contractor the total and full amount of US\$109,393.37 (One Hundred-Nine Thousand-Three Hundred-Ninety-Three United States Dollars-Thirty-Seven Cents). The Company (LPRC) shall pay 50% or US\$54,696.685 as advance payment to the Contractor upon submission of an advance payment guarantee to LPRC. The balance 50% or US\$54,696.685 shall be paid after delivery.

WARRANTY

5. It is mutually agreed and understood by the Parties that **EARTHTIME**, **INC**. is hereby warrantying that the Laboratory Equipment, Wares & Supplies will be free from defect in material and workmanship. The period of warranty is twelve (12) months or one (1) calendar year from the date of delivery.

This Agreement may be terminated by LPRC (Company) giving thirty (30) days written notice in the event that the operations of LPRC are interrupted because of security reasons as used herein, security reasons is defined to include but shall not be limited to conditions involving all cases of Force Majeure, including wars, riots, insurrections, civil commotions, strikes, lock-out Acts of God, explosions, floods and other causes beyond the influence and control of LPRC.
- 8. This Agreement may also be terminated by LPRC without notice if the Contractor commits a material breach of any term or condition of this Agreement as determined by LPRC (Company)

including but not limited to the Contractor failing to satisfactorily perform services required and engaging in unlawful acts as determined by LPRC.

- 9. The Parties hereto further mutually agree that nothing herein contained shall be construed to mean that a principal and agent relationship is intended by and between LPRC (Company) and the Contractor or that they are one and the same or that either Party has the right to bind the other; it being expressly understood and LPRC (Company) and the Contractor are independent Contractors and each Party shall be held harmless from any and all damage, loss or claim or whatsoever nature arising out of or in connection with their respective businesses and/or financial obligations.
- 10. There are no promises, terms, conditions or obligation other than those contained herein. This Agreement supersedes all previous communications, representations, agreements negotiations, or understandings, either verbal or written between the parties hereto.

The terms and conditions of this survey and monitoring contract shall be binding on the Parties hereto, their representatives, assigns, successors-in-business and interest, as if they were specifically named herein.
