Subject: PPCC RESPONSE: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO BROOKS BUSINESS CENTER FOR THE SUPPLY AND DELIVERY OF HIGH QUALITY PARBOLED RICE (LOT 1 - 50KG) AND PARBOILED RICE (LOT 2 - 25KG) - FISCAL YEAR 2022

We present our compliments and wish to acknowledge receipt of your letter and accompanying documents, which sought the approval of the Commission for the Liberia Petroleum Refining Company (LPRC) to award Contract to Brooks Business Center for the supply and delivery of High-Quality Parboiled Rice (Lot 1 – 50kg) and Parboiled Rice (Lot 2) at a cost of US\$181,440.00 and US\$123,440.00, respectively.

The Commission, upon review of your submissions, highlights the following:

- That the Liberia Petroleum Refining Company submitted (Hard copies) including: <u>bid</u> documents, <u>bid</u> evaluation report, <u>procurement committee meeting minutes</u>, <u>bid</u> opening <u>minutes</u>, <u>draft contracts</u>, <u>etc.</u>
- That LPRC instituted the National Competitive Bidding (NCB) method of procurement and only one (1) company submitted bid (Brooks Business Center);
- That as per the LPRC's BEP Report, **Brooks Business Center** was deemed responsive to stipulated requirements.

Thus, the Commission upon overall scrutiny of LPRC's submissions and accompanying documents, hereby states below:

- That a "No Objection" is rendered for the Liberia Petroleum Refining Company to award contract to Brooks Business Center for the supply and delivery of High-Quality Parboiled Rice (Lot 1 50kg) and Parboiled Rice (Lot 2) in the combined stipulated amount of three hundred four thousand nine hundred twenty United States Dollars (US\$304,880.00);
- That the LPRC is <u>advised</u> to ensure that "No Objection" requests are obtained from the PPCC before issuing notification of award to a bidder. This is key, for at times, the Commission review findings can reveal that a recommended responsive bidder <u>may not</u> be in conformance with pre-determined <u>requirements and qualifications</u> set by the procuring entity, and also not be in compliance with other procurement rules. This would then call for retendering or re-evaluation. Please note that this is in the best interest of the procuring entity for <u>safeguarding measures</u> and <u>ultimately to ensure compliance</u>.

Please note that all contracts which cumulative annual value above the threshold of U\$\$250,000.00 must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice. The Commission requires that you kindly forward copies of all stipulated contracts upon signing, so as to update our records.

The Public Procurement and Concessions Commission admonishes and it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimate public confidence in our procurement and
