Subject: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO GEO GREEN INTERNATIONAL FOR THE SUPPLY AND DELIVERY OF LABORATORY EQUIPMENT FOR FISCAL YEAR 2023.

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Liberia Petroleum Refining Company to award Contract to Geo Green International for the supply and delivery of Laboratory Equipment for FY 2023, in the amount of US\$460,489.84 (four hundred sixty thousand four hundred eighty nine and eighty four cents United States dollars), in accordance with Section 40 (3) of the PPCA, 2010 and Section 55(d).

That "No Objection" is rendered for the LPRC to award Contract to Geo Green International for the supply and delivery of Laboratory Equipment for the Fiscal Year 2023 in the amount of US\$460,489.84 United States dollars.

Please note that all contracts which cumulative annual value above the threshold of US\$250,000.00 must be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice.
