
- That the LPRCC should always categorize the beneficiaries to reflect the variant classes of employees to facilitate a uniformed pricing approach by interested Insurance firms.

Please note that all contracts which cumulative annual value above the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice. **The Commission requires that you kindly forward copies of all stipulated contracts upon signing, as required under governing procurement rules.**

The Public Procurement and Concessions Commission admonishes and deems it a priority that remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.


