Item	Contract Package	Description
1	Legal Consultancy	The LRA will hire a Legal Consultating firm for Domestic Tax and Custom cases, non-tax cases, litigations and including provision of professional advice. This services require that a particular consultant or firm be selected due to his or her unique qualifications.
