Subject: "NO OBJECTION" TO USE FRAMEWORK CONTRACT AGREEMENT TO AWARD CONTRACT TO SUPER PETROLEUM FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS (LOT 1-DIFSEL-BULK AND LOT 2&3-GASOLINE-COUPONS)-FISCAL YEAR 2022.

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Liberia Water and Sewer Corporation (LWSC) to award a framework contract to Super Petroleum for the supply and delivery of petroleum products (Lot #1-Diesel Bulk Fuel and Lots 2&3-Gasoline and Diesel coupons in the amount of US\$533,170.00 (five hundred thirty-three thousand one hundred seventy thousand United States dollars) and US\$249,900.00 (two hundred forty-nine, nine hundred United States dollars) respectively.

The Commission, upon review of your submissions, highlights the following:

- That the Liberia Water and Sewer Corporation submitted (Hard copies) including: bid documents, bid evaluation report, procurement committee meeting minutes, bid opening meeting etc.;
- That LWSC invited 8 (eight) companies and only 2 (two) companies participated in the bidding process (Aminata and Sons, Inc., and Super Petroleum Company), as per the submission:
- That I WSC's BFP Report shows that Super Petroleum was deemed the responsive winner as per LWSC's submission.

The Commission, upon overall review of your submission renders "No Objection" for the Liberia Water and Sewer Corporation to award a framework contract to Super Petroleum Company for the supply of the goods as indicated above and in the stipulated combined monthly amount not to exceed US\$65,255.83 (sixty-five thousand two hundred fifty-five United States dollars and eighty-three cents).


