Subject: NO OBJECTION TO AWARD CONTRACT TO MAYOUBAH & SONS, INC. AND AMINATA & SONS FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCT FOR FISCAL YEAR 2019/2020

We present our compliments and acknowledge receipt of your letter referenced above, which informed the Commission that the Liberia Water and Sewer Corporation (LWSC) intends to award a framework contract to Mayoubah & Sons, Inc. for the supply and delivery of bulk fuel Lot 1 ("the Goods") for a monthly amount not to exceed US\$ 27,710.00 (twenty-seven thousand, seven-hundred and ten United States dollars) and (Lot 2), coupons to Aminata & Sons for the monthly amount not to exceed US\$ 24,202.80 (twenty-four thousand, two hundred and two United States dollars Eighty Cents).

The Commission upon review and scrutiny of all submitted documents and subsequent clarifications hereby renders <u>Approval</u> and states that the Liberia Water and Sewer Corporation proceed to sign a framework agreement with the selected bidders for the supply of the Goods aligned with the stated Lots indicated above.

The Commission advises the Liberia Water and Sewer Corporation that non-SBA eligible businesses should not be invited for an indicated contract package on the SBA Procurement plan. The Commission also advises the LWSC, that if cost is attached (if deemed necessary by the procuring entity) to a bidding document, it should be reasonable to reflect Only the cost of printing and distributing of the bidding documents in accordance to PPCA Section 58(2).

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of US\$250,000.00 must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement & Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability. fairness equality and ultimately public confidence in our procurement and concessions processes.
