Subject: **"NO OBJECTION TO AWARD CONTRACT TO SANOE L. ENTERPRISE AND PETRO TRADE FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS FOR FISCAL YEAR 2023."**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Liberia Water and Sewer Corporation award Petroleum Contract to Petro Trade for the supply of Gasoline and Fuel in Coupons (**Lot: 2**) in the amount of **US\$205,322.25 (two hundred five thousand three hundred twenty-two United States dollars & twenty five cents)** for Fiscal Year 2023 in accordance with Section 40 (3) of the PPCA, 2010 and Section 55(d).

The Commission, upon review of your submissions, highlights the following:

- That the LWSC submitted (Hard copies) including: Draft Contract, Bid Evaluation Report;
- That the LWSC cannot be granted "No Objection" for (Lot:1) and that the LWSC is advised to retender (**Lot:1**) given bidders non-responsiveness to stipulated requirements, by inviting all bidders and noting all the stipulated observation, to ensure transparency, competition and proper execution of procedures to yield best options.

The Commission, upon overall review of the LWSC's request and justification states below:

That "No Objection" is rendered for the Liberia Water and Sewer to award Contract to Petro Trade for the supply of Gasoline and Fuel in Coupons (Lot:2) in the amount of **US\$205,322.25** for the delivery of gasoline and fuel in coupons.

Please note that all contracts which cumulative annual value above the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
