We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Ministry of Gender, Children and Social Protection Special Project Procurement Plan (*Goods and Services*) for Fiscal Year 2019/2020 in accordance with Section 40 (3) of the PPCA, 2010. However, the Commission advises that the Ministry of Gender, Children and Social Protection include this procurement in the Ministry's Annual Budget, to allow proper and adequate planning for subsequent scrutiny by the Commission, so as to avoid requesting urgent approvals from the Commission for these foreseeable Celebrations.

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

Please be reminded to duly submit your contract award information for all procurement contracts awarded in the previous fiscal year (2018/2019), for stated submission will serve as a precursor for the Commission granting you final approval of your procurement plan for fiscal year 2019/2020.
