### 1.0 Introduction and Summary

In keeping with Sections 27(g) and 43(9), of the Amended and Restated Public Procurement and Concession Act which requires each Procuring Entity to submit quarterly report to the Commission, I am pleased to submit the Procurement Report for 1<sup>st</sup> Quarter (Jan – March), 2<sup>nd</sup> Quarter (April - June) and 3<sup>rd</sup> Quarter (July - September) 2022 for your review and consideration.

During the period under review, the Ministry of Agriculture/SADFONS Project has completed the implementation of Ten (10) packages implemented out of the Fifteen (15) planned Contract Packages of contract packages within our approved procurement plan for the period under review.

Out of the total procurement activities implemented thus far, the RFQ method was used for the acquisition of Eight (8) contract packages, the NCB method of procurement was used for the acquirement of One (1) contract packages whereas One (1) was acquired through the use of SS.

Subsequently, the Procurement Plans were updated in April 2022 and submitted to the Commission for approval and they were approved. During the execution of the Procurement Plans, the Project completed the implementation of Nine (9) packages out of the Sixteen (16) planned Contract Packages amongst contract packages within our approved procurement plan for the period under review.

Out of the total procurement activities implemented thus far, the RFQ method was used for the acquisition of Seven (7) contract packages, the NCB method of procurement was used for the acquirement of One (1) contract packages whereas One (1) was acquired through the use of SS.

#### 2.0 Challenges
