

Subj: REQUEST FOR "NO OBJECTION" USE THE SOLE SOURCE METHOD OF PROCUREMENT TO AWARD CONFRACTS TO AUGUSTINE FURNITURE FOR THE SUPPLY AND DELIVERY OF ASSORTED OFFICE FURNITURE.
