CONSULTANCY CONTRACT

THIS CONTRACT is made and entered into this 1st day of July, A.D. 2021 by and between the Ministry of State for Presidential Affairs, represented by and thru its Deputy Minister, Honorable G. Wesseh Blamoh, (referred to as the "**CLIENT**"), and Mr. Christian Chea, Sr. (referred to as the "**CONSULTANT**"). The Client and the Consultant are herein collectively referred to as the "**PARTIES**".

WITNESSETH

WHEREAS, the Client is in incessant need of a trained professional to provide advice on legislative matters and liaise between the Client and the Legislative Branch of Government;

WHEREAS, the Parties have agreed to enter into a new Contract, and;

NOW THEREFORE, the Parties agree as follows:

ARTICLE I: SCOPE OF WORK

- 1.1 The Consultant shall, pursuant to the request of the Client, perform the following services:
- Liaise with the Office of the President to ensure that all Executive Bills and requests to the Legislature are promptly placed before the Legislature for appropriate actions and/or reactions thereto;
 - Follow up on all pending legislation for and in the interest of the Client, which may not have obtained the due attention of the Legislature;
 - Follow up on all other matters of interest to the Client, including all such matters which have remained unresolved and pending before the Legislature;
 - Prepare an annual review of the progress of the Legislative Agenda of the Administration;
 - Provide advice on legislative matters, and arrange and coordinate regular consultations between the Client and the Legislature;
 - Perform such other services as may be requested by the Client.
- 1.2 The Consultant shall report directly to the President or such other person(s) as the President designates, on all matters pertaining to the Consultant's work with the Legislature and other activities that the President may from time to time assign to him.

ARTICLE II: DURATION OF THE CONTRACT

- 2.1 This Contract shall be valid for the period of six (6) months certain, beginning July 1, 2021 and ending on December 31, 2021.

ARTICLE III: REMUNERATION

- 3.1 In consideration of the services to be rendered by the Consultant, the Client shall pay the Consultant the sum of **One Thousand Eight Hundred Seventy Five (US\$1,875.00) United States dollars** monthly in arrears for each month of the contract period worked.
- 3.2 The Client shall cover the cost of any reasonable expenses incurred by the Consultant in performing the services under this Contract without any deductions from the Consultant's remuneration, provided that such expenses have been approved by the Client.

ARTICLE IV: EXCLUSIVITY

- 4.1 Nothing in this Contract shall be construed as granting either Party exclusivity to the services which the Consultant shall provide to the Client.

ARTICLE V: TERMINATION

5.1 It is hereby understood and mutually agreed by the Parties that the Client may, upon thirty (30) days advance written notice, terminate this Contract prior to its expiration for any of the following reasons:

- a. Lack of capability on the part of the Consultant to perform the services agreed to in this Contract;
- b. Persistent disregard by the Consultant of his contractual obligations or instructions from the Client;
- c. Violation of any law or regulation governing the Consultant's professional conduct in connection with the services to be rendered;
- d. Unsatisfactory performance by the Consultant of the terms and covenants herein stipulated;
- e. This Contract may also be terminated if at any time the services for which the Consultant is hired are no longer financially justifiable to the Client.
- f. The Consultant also reserves the right to terminate this Contract upon a thirty (30) days advance written notice to the Client, due to failure on the part of the Client to make payment of the contract fee as agreed herein.

ARTICLE VI: MISCELLANEOUS

6.1 This Contract may not be assigned in part or in whole to any third party without the expressed written consent of the Client.


6.2 This Contract represents the entire agreement between the Parties and is binding on the Parties hereto.
