The Commission, upon scrutiny of your submissions, hereby grants "No Objection" for the Ministry of Mines and Energy to extend contract with Diamond Counsel International for the provision of Independent Diamond Valuation and Training Service for a monthly amount not to exceed ten thousand four hundred sixteen United States Dollars and sixty-six cents (US\$10,416.66), consistent with Section 55 (1) (e) of the PPCA.

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of US\$250,000.00 must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.
