
We present our compliments and wish to acknowledge receipt of your communication dated March 20, 2025, which sought the approval of the Commission for the Ministry of National Defense (MOD) to award contract to Aminata and Sons Inc. for the supply of petroleum product ("the Goods") at an estimated cost not exceeding three hundred fifteen thousand four hundred eighty United States Dollars (US 315,480.00) for seventy-four thousand nine hundred thirty-five (74,935.886) gallons of diesel fuel for a unit price of four United States Dollars and twenty one cents (US \$4.21).

The Commission upon thorough review of your documentation submitted reveals that the MOD's request was accompanied with adequate documentation and is in keeping with section 31 of the PPCA, 2010. Therefore, the Commission hereby grants an approval to the Ministry of National Defense (MOD) to award contract to Aminata and Sons, Inc. for the supply of the "Goods" at a cost not exceeding the estimated cost indicated above.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.

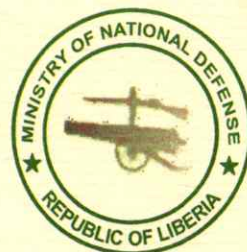
