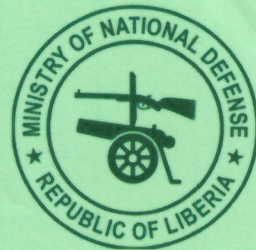

Subject: **"NO OBJECTION" TO USE FRAMEWORK AGREEMENT TO AWARD CONTRACT TO ANITA GROUP OF COMPANIES FOR THE SUPPLY AND DELIVERY OF RICE (DRY RATION) FISCAL YEAR 2023**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the **Ministry of National Defense** to award a framework contract to Anita Group of Companies for the supply and delivery of rice (Dry Ration) for a unit cost of **US\$22.00** and a total cost of one million five hundred thirty-seven thousand two hundred seventy-two United states Dollars **US\$1,537,272.00**.

The Commission, upon review of your submissions, highlights the following:

- That the Ministry of National Defense submitted (**Hard copies**) including: bid documents, bid evaluation report, procurement committee meeting minutes, bid opening minutes, draft contract, etc.;
- That the MOD's BEP Report indicates that MOD employed the National competitive Bidding and only one company (**Anita Group of Companies**) submitted bid;
- That **Anita Group of Companies** was substantially in compliance with the requirements set forth by the Ministry of National Defense in its bid document issued.

The Commission, upon overall review of your submission renders "No Objection" for the **Ministry of National Defense** to award a framework contract to Anita Group of Companies for the supply and delivery of rice (Dry Ration) for a total cost of **US\$1,537,272.00 (US\$22.00 per bag)** and for a monthly amount not to exceed **US\$170,808.00**.

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, **primarily**, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.
