We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Ministry of National Defense Special Project Procurement Plan. The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA 2010 as we jointly aspire to ensure the National interest is assured and ultimately public confidence is maintained in all Public Procurement and Concession processes.
