Subject: REQUEST FOR "NO OBJECTION" TO USE THE SOLE SOURCE METHOD IN FAVOR OF BUILDING MATERIALS CENTER FOR RENOVATION WORKS.

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for Ministry of National Defense to use the Sole Source Method in favor of Building Materials Center for Renovation Works on the Camp Whisner Barracks in Grand Gedeh County, Camp Todee Barracks in Montserrado County. the RIA Highway Military Barracks in Margibi County and the Lofa County Barracks for the recruitment of the AFL.

The Commission, upon review of your submissions, highlights the following:

- That the Ministry of Defense had conducted a competitive process earlier;
- That the Ministry of Defense Procurement process was approved by the Commission as evidence by the "No Objection" issued to MOD to award contract to Building Materials Center for the supply of building materials;
- That the Ministry of Defense has duly complied and satisfied all conditions for Single Source, since it already has an existing contract with the supplier for FY 2021 consistent with Section 55(1)(b).

The Commission, upon overall review of your submission renders "No Objection" for the MOD to use the Sole Source Method in favor of Building Materials Center for Renovation Works.

The MOD is reminded that all contracts which cumulative annual value exceeds the threshold of US\$250,000 must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, primarily, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.

Subject: Request Approval to Sole Source Building Materials from Current Supplier

Dear Atty Kowo:

I present my compliments and writes to request "No Objection" to Sole-Source additional building materials from Building Material Center in keeping with Section 55 of the amended and restated Public Procurement and Concession Act (PPCA) of 2010.

The Ministry wishes to further inform you of the following circumstances that substantiate its need to sole-source:

- 1. We have an unusual and compelling urgency to source additional building materials to be used by the Armed Forces of Liberia Engineering Company to carry out renovation works at Camp Whisner Barrack in Grand Gedeh County; Camp Todee Barracks in Montserrado County; RIA Barracks in Margibi County and Lofa Barrack in Lofa County in preparation for the scheduled nationwide military recruitment process.
- 2. That any delay in the renovation of these barracks will delayed the Armed Forces of Liberia nationwide military recruitment drive which will negatively impact the force ability to augment its strength to undertake the combined missions of providing troops for peace- keeping operation, and securing the borders during the 2023 National Elections.
- 3. That the Ministry of National Defense has a current contract with Building Material Center for the supply of building materials to renovate the EBK

Military barracks and need to extend said contract to allowed for the supply of additional materials for the renovation of the other military barracks.
