

# Supply of Petroleum Products Framework Agreement

Framework Agreement for **SUPPLY OF PETROLEUM PRODUCTS (Diesel Fuel)**. This Framework Agreement for **SUPPLY OF PETROLEUM PRODUCTS (Diesel Fuel)** is made and entered into and executed this 15 day of July AD 2021 by and between the Ministry of Nation Defense, represented by the Minister of National Defense, Honorable Daniel D. Ziankahn, Jr. of the city of Monrovia, Liberia (hereinafter referred to as the BUYER) and the Aminata & Son, Inc., represented by its president and Chief Executive Officer, Mr. Emmanuel I. Togba, also of the City of Monrovia, Liberia (hereinafter referred to as the SUPPLIER) and collectively for the purpose of this agreement, referred to as the PARTIES.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

WHEREAS, the Buyer has demonstrated and expressed the need for the **SUPPLY OF PETROLEUM PRODUCTS**, and

WHEREAS, the Supplier has presented itself to the Buyer as having the capacity and ability to supply the required quantities and quality of **PETROLEUM PRODUCTS** and the Supplier has agreed to supply the Buyer with the quantity and quality of the product requested to meet the Buyer's operational need for the duration of this contract.

NOW THEREFORE, for and in consideration of the foregoing the parties agree to the following:

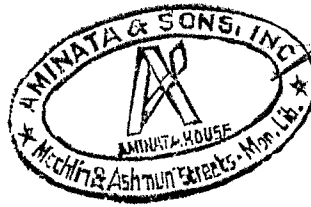
1. That the Supplier agrees to provide the Buyer with **SUPPLY OF PETROLEUM PRODUCTS (Diesel Fuel)** at the agreed price of Three Dollars Sixty three Cents United States Dollars (USD3.63) for six months during the fiscal year (FY) 2021
2. That the Supplier shall deliver the specification of **SUPPLY OF PETROLEUM PRODUCTS (Diesel Fuel)** to the Buyer starting July 2021 to December 31, 2021
3. It is mutually agreed between the parties that the Buyer shall make payment of the quantity and quality of **SUPPLY OF PETROLEUM PRODUCTS (Diesel Fuel)** supplied by the Supplier through the Government of Liberia Voucher Payment System on a quarterly allotment/disbursement basis upon the submission of the Supplier's for a given month.
4. It is further mutually agreed by the parties that upon the failure of the Supplier to deliver the **SUPPLY OF PETROLEUM PRODUCTS (Diesel Fuel)**, the Buyer shall notify the Supplier by writing for the first offense. Failure of the Supplier to comply or to remedy the situation, the Buyer shall have the right to abrogate this agreement and enter into an agreement with any other supplier of its choice for the supply of **PETROLEUM PRODUCTS (Diesel Fuel)**.
