Subject: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACT TO MONSIO HOUSE OF STYLES FOR THE SUPPLY OF MILITARY UNIFORMS AND GEARS FOR FY -2020/2021.

We present our compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the Ministry of Defense to award contract to Monsio House of Styles for the supply and delivery of military uniforms and gears (the "Goods") in the amount of three hundred eight thousand five hundred United States Dollars (US\$308,500.00).

The Commission upon review of your submissions, states the below:

- That MOD submitted the (Hard copies): Bidders submissions, bid document, minutes of bid opening, draft contract, cover letter and bid evaluation report and other accompanying documents;
- That as per the MOD's BEP's report, eight (8) firms were invited to participate in its Restricted Bidding process with Monsio House of styles emerging as the most responsive bidder;

Thus, the Commission, upon review of the MOD's request, clarifications communicated by the MOD, and the accompanying documentations and explanations, renders "No Objection" for the MOD to award contract to Monsio House of Styles for the supply and delivery of military uniforms and gears (the "Goods") in the amount of three hundred eight thousand five hundred United States Dollars (US\$308,500.00).

The MOD is advised to negotiate with Monsio House of Styles given the lone submission for this contract package.

Please note that all contracts which cumulative annual value above the threshold of US\$250,000.00 must be attested by the Minister of Justice and signed by the Minister of Finance, and also go through all subsequent requisite approval procedures where applicable. The Commission requires that you kindly forward copies of all stipulated contracts upon signing, as required under governing procurement rules.

The Public Procurement and Concessions Commission admonishes and deems it a priority that remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.
