We present compliments and wish to notify you that the Public Procurement and Concession Commission, upon receipt and overall review of your communication, accompanying documents and relying on your clarifications and assurances, has thus approved the **Ministry of Defense Special Project Procurement Plan (General Military Materials)**, for fiscal Year 2020/2021 in accordance with Section 40 (3) of the PPCA, 2010. The Commission informs the MOD that its Special Project Procurement Plan has been duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plan.


The Commission also states that Ministry of Defense update its submitted Restricted Bidding shortlist of potential suppliers for (Specialized Military Materials), to include more firms (from 5 – 8 or more) to primarily yield Competition and Value for Money.

The Commission counsels that you observe Section 40(5) of the PPCA, 2010 which states “each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. An updated procurement plan shall accompany said notice to the Commission.”

Please be reminded to duly submit your contract award information for all procurement contracts awarded in the previous fiscal year (2019/2020), for stated submission will serve as a precursor for the Commission granting you final approval of your procurement plan for fiscal year 2020/2021.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, **Value for Money** and **ultimately public confidence** in Liberia’s public procurement and concessions processes.

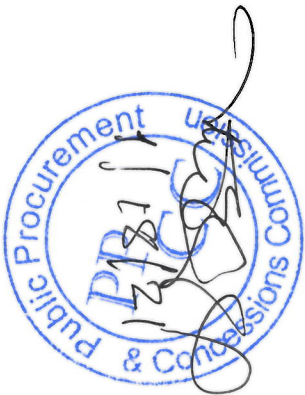
