We present compliments and wish to notify you that the Public Procurement and Concession Commission, upon receipt and overall review of your communication, accompanying documents and relying on your clarifications and assurances, has thus approved the <u>Ministry of Defense Special Project Procurement Plan (General Commission informs the MOD</u> that its Special Project Procurement Plan has been duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plan.

The Commission also states that Ministry of Defense update its submitted Restricted Bidding shortlist of potential suppliers for (Specialized Military Materials), to include more firms (from 5 – 8 or more) to primarily yield Competition and Value for Money.
