

REQUEST FOR "NO OBJECTION" TO USE THE SOLE SOURCE METHOD OF PROCUREMENT TO AWARD CONTRACT TO INTERIOR PERSPECTIVE FOR THE RENOVATION OF MATERNAL SITUATION CENTER FOR DATA ANALYSIS, G2 PHARMACY FOR THE SUPPLY OF ANTENATAL AND POST ABORTION CARE DRUGS AND SURGIMED LIBERIA LIMITED FOR THE SUPPLY OF (3X3) KVA POWER BACK UP BLOOD STORAGE FREEZERS AND BLOOD BAGS.

We present our compliments and wish to acknowledge receipt of your communication dated March 19, 2025, which sought the approval of the Commission for the Ministry of Health (MOH) to use the sole source method of procurement to award contract to Interior Perspective for the renovation of Maternal Situation Center for Data Analysis ("the Works") at an estimated cost of one hundred thousand United States Dollars (US \$100,000.00), G2 Pharmacy for the supply of Antenatal and Post Abortion Care Drugs ("the Goods") at an estimated cost of eighty thousand United Sates Dollars (US \$80,000.00) and SurgiMed Liberia Limited for the supply of (3x3) KVA Power Back Up Blood Storage Freezers and Blood Bags ("the Goods") at an estimated cost of twenty-five thousand United States Dollars (US \$25,000.00).

The Commission, upon thorough review of your documentation submitted, <u>hereby</u> grants an approval to the Ministry of Health (MOH) to use the sole source method of procurement to award contract to Interior Perspective for the renovation of Maternal Situation Center for Data Analysis ("the Works"), G2 Pharmacy for the supply of Antenatal and Post Abortion Care Drugs ("the Goods") and SurgiMed Liberia Limited for the supply of (3x3) KVA Power Back Up Blood Storage Freezers and Blood Bags ("the Goods") at the above estimated costs.

However, the Commission request that the Ministry of Health kindly submit the qualification documentation, quotations and draft contract of the above-mentioned vendors.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain in compliance with the PRCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.

### Request for No Objection for Reduction in Lead Time and Single Source for Procurement Packages

I present my compliments and herewith request the Commission's **No Objection for reduction in lead time for a period of one (1) week and to single source some of the below packages** with funding source (5993). The Donor has given a timeline of two weeks to the Ministry of Health to utilize all the allocated funding.

Background

These are facts and justification for the purpose of **No Objection** consistent with the time line for the utilization of donor (5993) funds. The need for this funding is even more urgent, especially now that the sector is seriously challenged with the reduction in USAID support to the health system.

For your consideration, the Ministry of Health has an obligation to ensure smooth operations in fulfillment to attain appropriate and optimum health outcomes of the Liberian populace.

### MOH Recommendation

Findings show that the donor (5993) has given the Ministry of Health funding to support the health sector in areas such:

- 1. Renovation of maternal situation center for data analysis \$100,000.00- (Interior Perspective)
- Procurement of antenatal and post abortion care drugs @ \$80,000.00-(G2 Pharmacy)
- 3. Procurement of (3x3) KVA power back up blood storage freezers & blood bags @ \$25,000.00-(SurgiMed Liberia Limited)

Hence, the Ministry seeks your approval for **No Objection** for reduction in lead time and to single source antenatal and post abortion care drugs package to G2 Pharmacy, blood storage refrigerator package to SurgiMed Liberia Limited as well as renovation of maternal situation center for data analysis to Interior Perspective.
