We present our compliments and wish to acknowledge receipt of your communication responding to the Commission's query for the Ministry of Health (MoH) request as indicated above.

Based on the review, the Commission is pleased to highlight the following from the Ministry's response to the Commission query:

- The Ministry of Health submitted the funding source through a FARA/G2G Health Partnership Activity budget summary.
- The Ministry of Health also submitted the proposed sole source provider quotation at US\$ 98,000.00 (Ninety-Eight Thousand United States Dollars)
- The Ministry further submitted the draft contract and the proposed provider qualification documents (Tax Clearance, Business Registration and others)

From the above findings, the Commission states that the request is consistent with **Section 55** (I) of the PPCA, 2010. However, the Commission further observes that the generator procurement is a central office procurement, which mandates the Ministry to utilize the e-GP System as one of the six (6) MACs currently using the system. Therefore, the Commission recommends that the Ministry implement this procurement activity utilizing the e-GP System.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain compliant with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality, and ultimately public confidence in our procurement and concessions processes.
