

“ After review and any modification done by the Hospital Procurement Committee, the Entity shall send a copy to your Commission for approval”.


Procurement process in the County will shortly commence if the plan is accepted and endorsed by the Commission.

We look forward to a speedy response to enhance quality health care services.

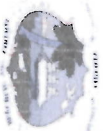

Property Lease (Non Bidding item/Not also in the Procurement Plan but an expenditure capture in the cash plan)

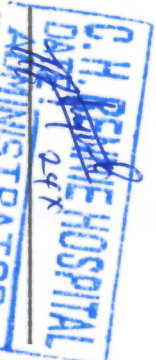
