Subject: REQUEST FOR "NO OBJECTION" FOR THE MINISTRY OF HEALTH TO AWARD CONTRACT TO IMRES B.V FOR THE SUPPLIES OF ASSORTED MEDICAL DRUGS
TO THE HEALTH SECTOR FOR FISCAL YEAR 2020/2021

We present our compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the Ministry of Health (MOH) to award contract to IMRES B.V for the supplies of assorted Medical Drugs ("the Goods) in the amount of three million three hundred eleven thousand four hundred twelve United States Dollars and thirty cents (US\$3,311,412.30).

The Commission, upon scrutiny of your submissions and clarifications, hereby grants "No Objection" for the MOH to award contract to <u>IMRES B.V</u>, in the combined total amount of two million five hundred eighty-two thousand eight hundred thirty-three United States Dollars and fifteen cents <u>US\$2,582,833.15</u>, for Lots one (1) to four (4) as stipulated below and as quoted by the most responsive bidder:

• LOT 1 (Regular Essential Medicines - US\$1,854,254.00

• LOT 2 (Mental Health Drugs)

- US\$119,960.00

• LOT 3 (Anesthetic Medicines)

- US\$67,075.00

• LOT 4 (IPC and Medical Supplies)

- US\$541,544.15

However, the Commission caveats that the MOH <u>must not render notification of award to any vendor</u>, <u>prior to the approval of the Commission</u>, and whilst review is being undertaken. Please know that the purpose of the <u>Commission's review by law</u>, is to authenticate processes and to ensure compliance before either concurring or rejecting with the proposed recommended bidder(s).

The Commission's review findings could reveal that the recommended responsive bidder, may not be in conformance with predetermined requirements or qualification set forth by the procuring entity, and other procurement rules. This would then consequently call for the procuring entity to retender or do a reevaluation. Please note that the Commission's scrutiny and review is in the best interest of the procuring entity, for safe guarding measures and to ultimately ensure compliance conformity.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
