We present our compliments and wish to acknowledge receipt of your letter, which sought the approval of the Commission for the Ministry of Justice to award contract to Termiziou Son Business Center for the supply of 17,770 Bags of Rice to the Bureau of Corrections and Rehabilitation in the amount of US\$355,400.00 (three hundred fifty-five thousand four hundred United States dollars) for the Fiscal Year 2023.

The Commission, upon overall review of your submission noting MOJ's justification, clarifications and accompanying documents states the below:

- 1. That "No Objection" is rendered to MOJ to award Contract to Termiziou Son Business Center to supply 17,770 Bags of Rice) in the amount of US\$355,400.00 (three hundred fifty-five thousand four hundred United States dollars);
- 2. That the Ministry of Justice understand that the Commission Provisionally approved the amount of US\$399,840 for food stuffs (Rice) and not the amount of US\$416,040 reflected in the Ministry's cover letter, dated March 30, 2023.
