We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the Ministry of Justice to sole source K. Dukuly and Sons, Inc. for the supply of rice for distribution to prison facilities across the country.

Please note that copies of final signed contract must be submitted to the PPCC, as required and validating purposes.

We present our compliments and write to provide clarity on the 'national security implications' that prompted our request for 'No Objection' to sole source in favor of K. Dukuly & Sons Inc. The issues surrounding the supply of rice to prisons across the country has the propensity, based on past experiences, to cause rioting in the various prisons across the country that may lead to prison breaks which is a threat to the security of the state.

Also, the lack of or inadequate supply of rice or food borders on human rights, as has been flagged in several Human Rights reports including the recent U.S. State Department report. This reflects on the image of the country. The Millennium Challenge considers the feeding and wellbeing of inmates as an issue of concern when considering Liberia's score card.

In view of the foregoing, we request your urgent response to our request for 'No Objection' in favor of K. Dukuly & Sons Inc.
