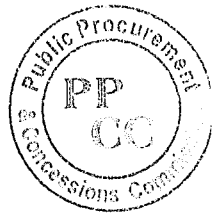


We present our compliments and wish to acknowledge receipt of your letter dated January 18, 2024 requesting to sole source **7,790 gallons** of fuel from **Petro Trade Liberia** at a unit price of \$5.39 per gallon for activities associated with the Monday, January 22, 2024 Presidential Inauguration.

The Commission, upon overall review and scrutiny of the Ministry's request and in consideration of the urgency and circumstance that precipitated, as well as meeting the condition of Section 55(d) of the PPCA 2010, interposes "**No Objection**" for the Ministry of State to sole source Petro Trade for the provision of 'the goods' at an estimated cost of **\$5.39** per gallon and a total cost of \$41,989.00.

In this regard, the Commission also request that you however submit a procurement plan, source of funding and quote from the selected supplier no later than Friday, January 19, 2024 prior to the execution of said transaction.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, Value for Money and ultimately public confidence in Liberia's public procurement and concessions processes.

Our Contract with the Petro Trade elapsed since December 31, 2023 and the bidding process has not begun due to the delay in the budget submission.

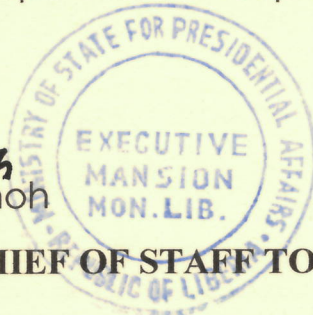
Your **No Objection** is needed to urgently Secure Fuel for the Inauguration.
