


Subject: RECEIPT AND APPROVAL OF THE MINISTRY OF STATE SPECIAL PROJECT PROCUREMENT PLAN (FURNITURE AND FIXTURES) FOR FISCAL YEAR 2022.

We present compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for Ministry of State's request for the use of sole source method and submission of its Special Project Procurement Plan (Furniture and fixtures). The Commission approves the MOS' Special Project Procurement Plan for Fiscal Year 2022 in accordance with Section 40 (3) of the PPCA, 2010, and informs the MOS that this Procurement Plan will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plans.

The Commission counsels that you observe Section 40(5) of the PPCA, 2010 which states "each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. An updated procurement plan shall accompany said notice to the Commission."

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
